- 2. **Have** time and commitment to serve Average 8 to 10 hours / month onsite and offsite or more if you can.
- 3. Have the time to be in the temple premises for majority of minor and/or major religious/cultural/fund raising events

- 5. Work as a team-player and consensus builder with positive mental attitude

The results are announced in the General Body meeting in April 2019 and the out-going Executive Board hands over the responsibility to the newly elected / appointed Board.
